National Thermal Power Corporation (NTPC) are the largest electricity producer in India. Their total installed capacity, including that under joint ventures, is close to 30,000 MW. 82% are coal-fired plants and 18% gas-fired. NTPC accounted for 28.5% of the total power generation in India in 2007.

ownership

NTPC is listed at the Bombay Stock Exchange of India Ltd and the Bombay Stock Exchange Ltd. At present the Government of India holds 89.5% of the company's equity.

energy plants, nuclear

14 Feb 2009 NTPC and NPCIL signed a Memorandum to incorporate a joint venture. NPCIL will have a 51% stake and NTPC 49%. The companies plan to build nuclear power plants with a cumulative capacity of 2,000 MW together. Specific projects are not yet decided upon. Later, NTPC aim to develop nuclear power plants on a commercial basis independently.
