## About Banco Votorantim

Banco Votorantim was founded in 1988 as a securities dealer, and started operating as a bank in 1991. Banco Votorantim has a business portfolio in wholesale banking, wealth management services and consumer finance. In 2009, [Banco do Brasil](#) obtained a 49.99% voting stake and a 50% overall share in Banco Votorantim. Since then, the bank is controlled by both Grupo Votorantim (the holding company) and Banco do Brasil. Banco Votorantim signed the Equator Principles in 2016, and is profiled as part of BankTrack's [Tracking the Equator Principles campaign](#).
