De Volksbank is a Dutch retail bank, providing various banking products and services for individuals and small businesses. The bank offers savings, payments, investments, asset management, mortgages, loans, and disability and term life insurance, as well as online and mobile banking services. It operates under the four brands, including ASN Bank, BLG Wonen, RegioBank, and SNS bank. The bank was formerly known as SNS Bank and changed its name to de Volksbank in January 2017. In 2013 SNS Bank was nationalised making the Dutch state the only share holder of de Volksbank. De Volksbank's headquarters are located in Utrecht, the Netherlands.
