On top of this, the dramatic situation in Ukraine required us to do our part in pressuring banks to withdraw their activities in Russia, as part of global efforts to impact on the Kremlin's revenue streams, while we also kept up pressure on bank initiatives such as the Equator Principles in the Net Zero Banking Alliance. All this good work is captured in the report in front of you.

case within the global banking sector, so we owe it to ourselves to always try, even when we cannot fully oversee the potential result of our own actions. In chaotic times it helps to focus, so we started 2022 with a brand-new mission, to 'challenge banks globally to act urgently and decisively on the unfolding climate crisis, the destruction of nature, the widespread violation of human rights and the risk of entering ever new pandemics'. Not only does our mission state on which global emergencies we demand banks to act, it also seeks them to act urgently and decisively, as anything less will not prevent said emergencies from further unfolding into catastrophes that directly threaten human civilisation as we know it.

It took us the better part of the year to realign our organisation so that it can indeed make a tangible difference on climate, nature, human rights, and pandemics. For each area we seek to track and expose finance flows from commercial banks to high impact business sectors; assess and strengthen bank policy commitments directly tackling the issues; research and block bank finance for 'Dodgy

Deals' that will only worsen the situation; directly engage with banks on policies and investment strategies relevant for these four issues; and finally, help strengthen the ability of social movements to publicly pressure banks to act.

Yet, it does not require an overly pessimistic attitude to life to observe that, despite the best efforts of BankTrack and many fellow campaigners, a great many indicators expressing the state of the world, or the banking sector for that matter, continue to turn deep red. Billions in bank finance still find their way to business sectors that directly contribute to the further destruction of the natural world and of our

climate, or that trample upon the human rights of millions of people. There is also little sign that those in charge of the banks we target begin to understand the sheer magnitude of the transformation required to bring their business in line with stopping the climate crisis from further unfolding, preserving the natural world for our children, ending human rights violations the world over and taking away the risk of ever new pandemics.

So much remains to be done, with so little time left to do it, which is another unique trait of the times we live in, that it is hard to not every now and then give in to despair about whether we will eventually succeed. But BankTrack's work is not driven by despair but by hope, not to be understood as a simple belief that eventually everything will be alright, but, as writer and social activist Rebecca Solnit once formulated, "as an embrace of the unknown. Hope locates itself in the premises that we don't know what will happen and in the spaciousness of uncertainty there is room to act. When you recognise uncertainty, you recognise that you may be able to influence the outcomes".

So we proceed, also in 2023, our 20th anniversary year, amidst the everyday perpetual change and chaos. But then was it ever different? That famous quote of Zhou Enlai in 1972 on the impact of the French Revolution later turned out to be a translation error. He had not been referring to the French Revolution of 1792 but to the Paris student uprising of 1968, just a few years earlier. Change, when in the middle of it, has always been difficult to interpret, yet 50 years later, few will dispute that those students of 1968 did change the world for the good, forever. It was all worth it.

#### Financial situation 2022, outlook 2023

In 2022 we managed to maintain the support of all our funders of 2021 but one (the Ecology Trust), while we also received a new one-off grant from a new funder. Nine grant makers have provided support for our activities in 2022, mostly on a multi-year basis. Having our income secured for a few years ahead allows us to better plan our activities and provides our staff with the job security they need to fully dedicate themselves to the job.

In 2022 we received support from the following nine funders (in alphabetical order):<sup>1</sup>

- Action Aid Denmark (AAD) provided a oneoff grant of €15,500 to jointly produce a report on Scandinavian bank finance for the fossil fuel industry.
- The Customer Union for Ethical Banking (CUB) continued to provide a grant of €3,000 to support a project on the Cooperative Bank. It will also support us in 2023.
- The 2021 €33,000 grant of the Ecology Trust (TET) was extended into 2022, with further support for our work in 2023 being considered.
- 4. The European Climate Foundation (ECF) renewed their support for 2022 (US\$ 110,000). It has committed to further support our work in 2023, not only for our ongoing 'Banks and Climate' campaign but also for two new projects aimed at bank finance for the steel industry and for the global coal industry (this in a partnership with two other organisations).
- The Denmark based KR Foundation (KRF/ KRU) committed in 2020 to renew their support for 2021 and 2022 (of €220,000). The KR Foundation also provided another €62,000 for our climate work over 2021-2023 through our work partner urgewald. It has committed itself to support our work also in 2023 and 2024.
- 6. We received a grant of €25,000 for our 'Banks and nature' campaign in 2021 and 2022 through our work partner **Profundo (PRO)**.
- 7. The **Rockefeller Brother Fund (RBF)** has provided a general-purpose grant of US\$ 115,000 for the period 2022-2023.

- The 11th Hour Project of the Schmidt Foundation (SCH) provided a new grant to support our Human Rights work in 2022-2024 (US\$ 250,000).
- 9. The US based **Tilia Fund (TIL)** in 2022 generously supported us with a generalpurpose grant of Euro 160,000 and has indicated a willingness to support our work in 2023 and 2024.

Our total paid staff capacity at the end of 2022 was 8.9 FTE, a slight increase compared to end 2021 (8.8 FTE). If interns are also considered, our staff capacity at end 2022 was 10.9 FTE. For 2023 we expect to grow paid staff capacity to at minimum 11.5 FTE paid staff.

#### **Salary policy**

The BankTrack Foundation in its employment policy adheres to specific sections of the Collective Labour Agreement of the Dutch welfare sector for 2021-2023 *(CAO Sociaal werk).*<sup>2</sup> Salary payments were in line with scales of this CAO, with salaries ranging between 7.1 and 13.13.<sup>3</sup> As per December 31st, 2022, the ratio between lowest and highest gross salary level was 1 to 2.46, equal to 2021.<sup>4</sup>

#### **Financial reserves**

BankTrack ended the financial year 2022 with an increase of our reserves, which on January 1st, 2023, had grown with € 6,205 to € 184,285, compared to €178,080 on January 1st, 2022. This increase results from donations and partner contributions.

### Notes to the financial statements for the year ended December 31, 2022

### General accounting principles for the preparation of the annual accounts

#### General

The annual accounts have been prepared in accordance with Title 9 Book 2 of the Dutch Civil Code. The principles applied in respect of the valuation of assets and liabilities and determination of the result are based on historical cost. Unless not stated otherwise, monetary assets and liabilities are shown at nominal value.

#### **Translation of foreign currency**

Receivables, liabilities and obligations denominated in foreign currency are translated at the exchange rates prevailing at balance sheet date. Transactions in foreign currency during the financial year are recognized in the annual account at the exchange rates prevailing at transaction date. The exchange differences resulting from the conversion as of balance sheet date, taking into account possible hedge transactions, are recorded in the profit and loss account.

#### Principles of valuation of assets and liabilities

#### Tangible fixed assets

Tangible fixed assets are valued at purchase price less depreciation. Depreciation is calculated on a straightline basis and is based on the expected useful lives of the assets. Maintenance expenditure is exclusively capitalized where this extends the useful life of the assets.

Other assets and liabilities

All other assets and liabilities are valued at face value, unless otherwise stated in these notes.

#### **Principles for determination of the results**

#### General

The result is determined as the difference between the fair value of the services provided and services performed one hand and the costs and otherwise burdens of the year, valued at historical cost.

#### INDEPENDENT AUDITOR'S REPORT

#### 1 Report on the audit of the financial statements 2022 included in the annual report

#### **Our opinion**

We have audited the financial statements 2022 of Stichting BankTrack, based in Nijmegen. In our opinion, the accompanying financial statements give a true and fair view of the financial position of Stichting BankTrack as at 31 December 2022 and of its result for 2022 in accordance with the 'RJ-Richtlijn 640 Organisaties zonder winststreven' (Guideline for annual reporting 640 'Not for-profit organisations' of the Ducth Accounting Standards Board).

The financial statements comprise:
