## **SUBJECT:**

WILL [NAME BANK] COMMIT TO END FINANCE FOR FOSSIL FUELS BEFORE GLASGOW?"

**SEPTEMBER 23, 2021** 

Dear Ms./ Mr. [NAME CEO],

With less than 40 days to go before the start of the Glasgow Climate Summit (COP26), we are writing to call on [BANK] to make the decisive shift that will be needed from every bank if this summit is to be a success, namely, to announce measures to rapidly end its finance for the fossil fuel sector (coal, oil, and gas). We consider this a necessary step to take for every bank that aims to align its operations with the 1.5-degree goal of the Paris Agreement.

The <u>latest IPCC assessment report</u>, released August 9, delivered a crystal-clear message: "Climate change is already widespread, rapid, and intensifying. Many of the changes observed are unprecedented in thousands, if not hundreds of thousands of years". The report also sent the stark warning that, "unless there are immediate, rapid, and large-scale reductions in greenhouse gas emissions, limiting warming to close to 1.5°C or even 2°C will be beyond reach".

These alarming findings led UN Secretary-General António Guterres to <u>declare</u> the report a "Code Red for humanity." He was also clear on what lies at the root of the current climate crisis: "greenhouse gas emissions from fossil fuel burning and deforestation are choking our planet and putting billions of people at immediate risk". He concluded, "This report must sound a death knell for coal and fossil fuels, before they destroy our planet".

That same clarity was already provided in May, when the International Energy Agency (IEA) published for the first time a comprehensive energy pathway towards achieving net zero emissions by 2050. The report stated unequivocally that, in order to achieve this goal, there "can be no further investment in new coal, oil or gas supply", with that position later clearly <u>reiterated</u> by EIA director Dr. Fatih Birol when commenting on planned oil exploration in the Northern Atlantic.

Aside from these decisive reports, we have in the last months all been witness to the devastating fires and floods that have brought misery and destruction to communities and nature worldwide, and heard the <a href="warnings of scientists">warnings of scientists</a> that such weather extremes will soon become the new normal, unless the world starts to take decisive action on curbing emissions right now, banks included.

## THE ROLE AND RESPONSIBILITY OF [BANK] IN FINANCING FOSSIL FUELS

Our March 2021 Banking on Climate Chaos report <u>revealed</u> that, since the Paris agreement of end 2015, [BANK] has provided finance for the fossil fuel industry worth over US\$ 97 billion. Of this sum, US\$ 43 billion went to the top 100 companies expanding fossil fuel production and infrastructure. Such financing for fossil



fuel expansion is particularly problematic because it locks in emissions for decades to come and makes it more difficult for the world to transition away from the use of fossil fuels.

Meanwhile, our analysis of [BANK's] existing policy commitments on fossil fuels shows that the bank until now does not have in place an adequate policy framework of forward-looking policies excluding the fossil fuel industry from financing and lacks adequate commitments to phase out existing financing. [BANK] scores 11.5 out of 200 total points, which places the bank in the **laggard** category of banks. When it comes to policies to exclude financing the *expansion* of the fossil fuel industry, [BANK] scores 5 points out of 82, again placing the bank in the **laggard** category.

We note that [BANK] announced in March that it is targeting net zero emissions in its lending portfolio by 2050. While we appreciate this step, we maintain that more must be done, urgently, to end your bank's financing of the fossil fuel industry as soon as possible.

## **STOP FINANCING THE FOSSIL FUEL INDUSTRY**

The <u>Global Call on Banks</u>, launched in May 2021 and now <u>supported</u> by 210 organisations from 39 countries, calls upon all banks to phase out their financing for the fossil fuel industry and promote a rapid, deep and just transition of our energy system away from fossil fuels. Concretely, civil society calls on banks to:

- 1. Immediately **end all financing for fossil fuel expansion** projects and for all companies expanding fossil fuel extraction and infrastructure, along the whole fossil fuel value chain.
- 2. Publish plans to **phase out all ongoing financing for fossil fuel projects and companies**, on a timeline aligned with limiting global warming to 1.5°C, starting with coal mining and coal power, as well as projects and companies active in tar sands oil, Arctic oil and gas, offshore oil and gas, fracked oil and gas, and LNG.
- 3. **Require all existing clients to publish phase out plans** for their fossil fuel activities on a 1.5°C-aligned timeline.
- 4. **Commit to zero out the climate impact of all financing before 2050**, and to halve this impact by 2030 at the latest, without relying on discredited offset schemes.
- 5. Immediately **end all financing for fossil fuel projects and companies that abuse human rights**, including Indigenous rights, and;
- 6. Publicly and comprehensively **report** on all the previous steps.

With this letter we urge your bank to move beyond your current policy commitments and to align its fossil fuel policy with this Global Call. We also call on you to announce your commitment to do so before the start of the Glasgow Climate Summit on October 31. Failure to do so will mark the bank as bearing direct responsibility for the further escalation of the climate crisis. The science is clear about the urgent need to bring the fossil fuel sector to an end, and the world cannot afford to see banks continue to finance the industry for decades to come.

We also call on you personally to show the leadership currently required from everyone in a key position to make a difference to help tackle and reverse this climate crisis. We thank you in advance for your courage to do so.

We would appreciate receiving a response on this letter before the start of the Glasgow Climate Summit.
